

# Forklift LiFePO4 Battery Warranty Card

Buyer needs to provide the valid purchase invoice or shipment waybill to verify the date of purchase.

If Buyer fails to provide the valid purchase invoice or shipment waybill, the standard Warranty period for Products starts from 90 days after manufacture date.

### Warranty Coverage and Void Conditions

Quarelex warrants that the LiFePO4 battery will retain at least 80% of its rated capacity for 5 years, provided that: a) the user manual is strictly followed, and b) all original seals, fasteners, and warranty labels remain intact, unaltered, and legible.

Failure to do so will void the warranty.</li> <li>Use lead-acid battery charger to charge the battery.</li> <li>Battery being flooded by water or burned by external fire.</li> <li>Exceeding maximum charge and discharge Current/Voltage in the manual book.</li> <li>User opens the battery without authorization from quarelex company.</li> <li>Damage in handling, including damage encountered during shipment by customer.</li> <li>Case damaged due to improper installation and storage by customer. Improper Installation, including, but not limited to the following:</li> <li>Loose terminal connections,</li> <li>Under-sized cabling,</li> <li>Mismatched cable sizes or lengths,</li> <li>Incorrect wire termination,</li> <li>Incorrect wire connections,</li> <li>Reverse polarity connections,</li> <li>Short circuit the battery</li> <li>Improper series or parallel connections</li> <li>Environmental damage due to inappropriate storage or operating conditions, exposure to extreme hot or cold temperatures, fire or water damage.</li> <li>Acts of God, including lightning, floods, earthquakes, fire, and high winds.</li> </ul>

### How To Make Warranty Claim

Note: quarelex reserves the right to reject the warranty claims without the necessary information required as below.

Step 1	Must switch off battery first, and Contact quarelex	When there is any problem happening, user MUST switch off the battery immediately. And contact quarelex technical support team immediately by Phone/Messenger/Whatsapp/Email, etc.
Step 2	Take picture of the nameplate sticker of the product	Customer must take clear picture of the name plate sticker of the product that clearly shows the SN code of the product.
Step 3	Take pictures and videos of the problem	Customer must take clear pictures and videos to record the problem, including but not limited to:  • Battery BMS detailed data on the battery LCD screen.  • Measure the voltage between battery terminals multi meter when battery switch turned on under instructions of quarelex company.

#### Freight Cost

Note: If the products can only be repaired by quarelex or need to be replaced by quarelex, freight cost will be shouldered as below.

If the products can be repaired or replaced by local distributor, the local freight cost between customer and distributor depends on local distributor policy.

quarelex-to-Buyer shipping cost	Within first 6 months of warranty period, quarelex will bear the quarelex-to-Buyer shipping cost.	
	After first 6 months of warranty period until warranty expires, Buyer will bear the quarelex-to-Buyer shipping cost.	
Customs Clearance Cost	Buyer shoulder the customs clearance cost of replacement parts or units if there is any.	

## No Liability for Damages
